•Discussed PPP forgiven loans. Objection made on not spending the PPP monies on personnel, recommending we should consider money already spent vs as a surplus. Finance Committee decided (not unanimously) that PPP loan will be used and reserved for Personnel and utilities as it was intended. Finance Board passed and then Council passed unanimously to make it a Reserve fund for Personnel use.

- ·Endowment fund continues to grow.
- Indication of what we are hoping to accomplish in 2022 with capital improvement to increase value of Riverside Church. Jaquelyn Light Fund may be increased and used to build a new deck, the Duringer Audio Visual fund to improved AV access within the church to support worships both in person and hybrid. Imagine next year to show a litany of different projects that we as a church can plan for.
- Riverside is in good financial positon and protecting deficit and capability to improve, however we need more members, more contributions, and need to balance the budget.

Dave Roth moved to amend and move \$350 from the photo fund from a liability to a donation from a member income, seconded by Ann Harris.

Kathy Watson moved to accept and adopt the amended 2022 budget, seconded by Ann Harris.

Leonard Wood clarified on endowment trust. Leonard, Janet and Charlie will continue to communicate.





My word for this year is rebuild.

The pandemic, which disrupted every aspect of our lives these past several years, has transitioned to an endemic. We have resumed many of our regular activities, with and without masks, while adapting to the need for occasional periods of individual quarantine.

With this transition, has come an opportunity to look around and see where the dust has settled. Who is still present and active in the life of RCC? Who have we lost? And, as the sprouting of several Christmas Eve "waterfalls" in the ceiling caused us to ask: what's the state of our building? Can we stay in this space? If so, what actions must we take in the coming weeks, months and years?

Fortunately, we have not journeyed over this shaky ground on our own. Indeed, the God of grace, goodness and renewal has been with us every step of the way. Below, I have highlighted just a few of the many ways that God guided us to renew and rebuild in 2022:

#### Worship & Music

We added new video and audio equipment, thanks to the Duringer Fund and many volunteers, that has enabled us to regularly offer livestreamed services. This has also greatly improved the sound quality in the sanctuary for in-person participants.

With the leadership of Diana Beterbide and Tim Mayer, we began re-building our Chancel Choir and Gospel Ensemble, with new members and a high level of energy and commitment.

The Music & Arts Board met quarterly, and provided a valuable resource for the design of worship and the integration of art into the sanctuary and beyond.

#### Staff

After the departure of Lorre Chester Rea in May, 2021 we began a long and challenging search for a new Office Manager. Fortunately, in June of this past year we hired Kathryn Murray to become our new "Office and Communications" Manager. Since that time, we've experienced a period of rebuilding and strengthening of many aspects of our administrative, communications and facilities related work.

#### **Community Outreach**

A highlight of my ministry at Riverside was the congregation's adoption of the "Train of Tears" declaration and the subsequent community event and public apology in May. It was an action of great courage and spiritual strength, and gave me great pride and gratitude for the gift of being in ministry with you.

Empowered by the Spirit, the leadership of Kathryn Murray and a heavenly host of volunteers, we re-launched an inperson Community Thanksgiving Dinner.

#### **Adult Education & Spiritual Nurture**

Highlights from 2022 include: a "Grounded Faith" series during Lent, "Church of the Wild" cohorts in summer and fall, continued weekly Bible studies at Down Manor, and an "Interfaith Circles of Solace" series in November & December.

We launched a regular series of "Moms Night Out" events to connect those parenting kids birth through high school.



#### **Camp Adams**

After a 3-year hiatus created by the pandemic, we were finally able to return to our beloved Camp Adams. The interest level was so high that we held two retreats—one in May and the other in early November.

#### **Pastoral Care**

The CHEERS team and members of our Prayer Shawl Ministry were important partners in providing pastoral care in 2022. In March, we were able to support the family of Laura Makepeace in grieving her death and celebrating her life.


#### Other

# JUSTICE AND WITNESS

Justice and Witness



Michelina Roth and Judy Schock. We met monthly to discuss and bring forth ways for us and our Riverside family to express our faith through our service. We also seek to provide opportunities for learning so that our service is informed and based on an understanding of justice, equity, diversity and inclusion. Here is a summary of our projects in 2022:

#### Black History Month Film Series -

Participants watch a movie each week, focusing on the African American roots of several music forms including spirituals, gospel, blues and jazz. We gathered each week on Zoom for discussion of the films and connection with each other.



## Ecumenical Ministries of Oregon's Reckoning with Racism Project -

Several members of the church, including two J & W committee members participated in this month's long process of exploring the role that racism played in the history of the UCC and to dive deeply into the history of our own congregations. The result lead to the Train of Tears event and a public apology declaration that Riverside offered to the Japanese-American community of the Hood River Valley.

#### **Immigrant Housing**

- In follow-up to the Train of Tears event, committee members felt that it was important to continue Riverside's efforts to recognize and act on issues of past and current injustice locally. One area of great concern is the need to support our immigrant neighbors. We identified housing as a key need. We shared this concern with several community members and the result has been the formation of a new coalition of church and community organization members meeting to partner on this issue. So far, the group is working on two potential housing options for transitional housing for immigrants/refugees in need.

Fridays for Future – Friday at noon rallies are still being held around the world in solidarity with Greta Thunberg. Though these rallies were not held as regularly in 2022, J & W team members stood with RCC youth on many occasions when they did

FISH Food Delivery Team - Seven RCC members and friends continue to be "at the ready" whenever there is a need for a food delivery. There has been substantially less need this year, but we do still get requests from our partner at The Next Door, Inc., Graciela Gomez. We made deliveries to at least 15 families this year.

Pockets of Plenty – This monthly offering includes a report offered by a representative from the organization or group to help members understand what they do and what their needs are.


2022 offerings went to Camp Adams, Casa Alitas (an immigrant support program on the border), Natives Along the Big River, Rowena Wildlife Center, Doctors Without Borders (to Tajikistan where RCC member Kim Humann is volunteering). POP offerings also go to UCC national campaigns including One Great Hour of Sharing and Strengthen the Church.

The Giving Tree – Warm clothes and socks are collected during the holiday season and decorate our Riverview Room tree. All items this year were donated to Hood River Shelter Services and to the Mobile Clothing Closet (serving local Native population)

Earth Month Film - Community members were invited to gather to watch and discuss the film, The Invisible Hand. This powerful film featured groups in several parts of the country who are working to legally establish the universal rights of nature and use these rights to protect rivers and lands

# BUILDING COMMITTEE

Pipe Organ-It began with addressing the Organ. In the past rainwater had seeped into the well in which the large pipes wind boxes sit. This made the organ unplayable. A difficult situation for a church known for its music. The Building Committee hired Bond Organ Builders to inspect and fix the problem. Bond rebuilt the wind boxes, moved them up on the level of the other pipes (about 2 ft. higher) and piped them into the base of the large pipes. They also sealed the area around the base. This doesn't guarantee there will never be water in this area, but it does insure the pipes should be operational under virtually all circumstances.



Drains -Joe Smith, Charlie Warren, Leonard Wood and others inspected and Chinook Plumbing corrected drains around the church building. When the church is finally reroofed additional work will need to be done to some of the gutters sloped improperly.

Deck off the Riverview Room - Riverside signed the contract with architect Liz Olberding to authorize work designing and doing Building Assessment & Code Analysis. Liz presented her findings to the Committee in early December. This project may require addressing ingress/egress issues, as well as ADA access to the church. Liz was asked to finalize code analysis with the County Building Inspector but also to explore other options which have presented themselves including a possible balcony with an ADA ramp from the back parking lot. We expect her findings and recommendations at the end of the first quarter. The conclusions of the **Building Assessment & Code Analysis will** help us determine if the building of the deck or balcony is feasible. This project is being funded by the Jacqueline Light Fund.

For each of the two gatherings, young Riversiders found a way to beat the heat with water toys, spray bottles and large buckets of water.

#### **Earth Camp**

The themes for this summer's Earth Camp were Reptiles, Oceans, Forests and Rivers. For Reptile Day, Shanti Kriens presented her Creature Teacher's program and the kids participated in her educational show that included live reptiles. Eric Bingener, gave a talk on ocean health, Bonnie New helped the kids use magnifying glasses to take a closer look at what grows in the forest, and Keith & Karen Harding, took us on a journey of Oregon's Rivers. Each day was packed with games, crafts, music (Pam Riedl & Anna Diem) and snacks (Lynne Davidson & Kathy Watson). Body movement was provided by Kim Morton.

#### OWL (Our Whole Lives)

The OWL program continues to serve 7-9th graders. In last winter's cohort, 22 students were served, and in the fall cohort, 15 students were served. The facilitation team members were Ann Becker, Elaine Thompson, Daron Ryan, Alicia Spiedel, Robin Henson and Katie Cook. The program provides developmentally appropriate information on topics which include gender identity and expression, accurate information about sexual health, justice and inclusivity, and healthy decision making. There are 33 students on the waiting list for next fall, to meet the demand for this program, five new facilitators will be trained in 2023.

#### **Youth Profiles**

Delaney Hackett, Sam Fauth and Anneliese Richardson were interviewed this year. This is a nice way to keep in touch with the ever -changing lives of Riverside's young people, and it gives an opportunity for the congregation to get to know the teens better.

#### Fall Fundraiser

Babysitting was provided for the fall fundraising event, and several teens helped. The kids enjoyed an evening of crafts, games, stories, and a movie while their parents attended the dinner and auction.

#### Pizza and Pumpkin Carving

After church, young families enjoyed carving spooky faces to make Jack O' Lanterns. James Holloway cooked the pizza which was enjoyed by everyone too.

#### **Greening of the Church and Advent Crafts.**

At the beginning of Advent, greens and wreaths are prepared by Riversiders after the worship service. This year, a Christmas pinecone Children's craft project was added Leftovers from the Community Thanksgiving meal were provided for lunch.

#### **Conservation Costa Rica Trip**

To offset the expense, most of the fundraising is being done by providing a soup/salad/bread luncheon after worship on the second Sunday of each month. They will visit a nursery to learn about planting /reseeding, visit the Arenal Volcano region to learn about natural thermal heat and watershed developments, and visit a coffee plantation to learn about how coffee is grown and processed.


#### **Church School and Nursery Care**



·Gean Rains worked extensively with Kathryn to transition our membership data from the former CDM software platform to Breeze. This process concluded in April.

Beyond that, Gean helped Kathryn scrub our membership rolls of names no longer active in the church. Final total: 85 active members (per bylaws specifications), and another unofficial "friends of Riverside"

Charlie Warren worked with building committee and outside vendors to compile, complete, revise and submit for Council approval the first Riverside Church Capital Improvement Plan. By priority, it lists, describes and estimates costs for completion 25 projects over the next 20 years. High priority projects will cost a combined \$596,000 (inflation and contingency adjusted). Desirable projects will costs another \$352,994. Combined costs comes to \$948,994.

Donated or saved funds earmarked for specific projects will reduce the total by \$185,000. Net estimated costs requiring additional funding support comes to \$763,994.

Based on imminent and deferred repairs, we informed council of need to consider a capital campaign. Lacking internal skill to undertake such a project, we looked to the United Church of Christ Building and Loan fund for possible financing, which they quoted at 4.5% per annum, in mid-summer. That figure has likely changed since then. Before incurring debt or tapping RCC reserves to fund repairs, Council discussed and approved engaging UCC consultant Jill White to lead a visioning process to undergird creation of RCC's first strategic plan.



## GIVING CAMPAIGN

The Blessed to Be a Blessing "hybrid" campaign was repeated this year, with pledge material being emailed and delivered in person, along with cookies made by our wonderful Kathy Watson, Chair of All Things Yummy. The official campaign began on November 13 and concluded on November 27, 2022. This year, members and friends of Riverside were encouraged to make a 5% increase in their pledge from the previous year.

As in the past, congregation members have presented "Blessed to be a Blessing" moments during worship. These moments provide an opportunity for members to share what they value at RCC and why they contribute regularly. The "Blessed to be a Blessing 2021" campaign shows continued growth in our congregation and our ability to share God's message locally and beyond.

A small complication with the Campaign this result was a result of the church switching to a new management software program, BREEZE.. This meant those who donated electronically needed to enroll into the BREEZE system to continue making donations after January 1, 2023.

As of January 20, 2023, 75 pledges had been received for a total of \$175,089. This is an increase of more than \$15,000 from the previous year. Over 60% of returning pledgers increased their pledges, while 25% kept their pledges at the same level.

## GIVING CAMPAIGN

#### Highlights of the 2023 campaign:

- This current number of pledges is slightly lower than last year at this time, when we had 77 total pledge units for 2022.
- Of the 73 total pledges, 5 are new donors from 2022 - they account for approximately 2/3 of the \$15,000 increase.
- Due to decreased or discontinued pledges from 2022, the net gain for the 2023 campaign is only \$2,200 as of this report. (reduction of the \$15,000 gain)
- If the number of pledgers for 2023
  increase to the same level as 2022, total
  projected income is approximately
  \$177,000 roughly \$6,000 more than
  2022 (a 4.6% increase close to the
  campaign goal).
- Pledges range from \$25 to \$1,075 per month, with an average pledge of \$2,484 per year.

## TREASURER REPORT



Charlie Warren RCC Treasurer

I wish to thank the congregation of Riverside Community Church for the opportunity and responsibility for administering the Budget for 2022 and the proposed 2023 budget.

2022 summary of Budget- The annual budget was set at 311,204 as adopted by the congregation in the January 2022 meeting. A projected deficit of \$29,929 made for a challenge.

I am pleased to state the end of year report by our accountant, Eric Fauth shows a deficit of just \$653.30.

## Budget Factors occurring in 2022: Revenue

- Riverside has an Endowment Fund that is used as investment capital for the future. We transfer 4.5% of the 3 year average to our Operating Fund. The beginning amount was \$603,673. We sustained a sizable loss in market value for our investment in 2022. The 2022 budget included a transfer into the general fund of \$23,450. Ending balance is \$494,344.

- Two PPP loans of \$31,667 each were received and forgiven. While this could have increased revenue significantly the council directed that these funds be set up as a Personnel Reserve fund for future years. Based on direction from council and the congregation we used these funds for covering proposed wage increases in 2022. A transfer of \$24,236 into the 2022 budget helped. This left \$53,995 in the fund at end of year 2022.
- Giving Income including Pledged and Unpledged contributions came in at \$195,717 vs budgeted \$190,000. Donations that have not been counted on in our budget process such as the \$10,000 donation from the Lake Foundation have significantly improved our revenue.
- -Building use was nearly on budget at \$31,075. The space in our downstairs is now occupied.
- Fund raising was budgeted at \$10,000 and a very successful yearly fundraiser brought in \$25.354.
- As a result of the above factors net revenue increased by over \$25,000.

#### **Expense**

- -Administration and office expenses budgeted at \$46,105 came in at \$50,176. Net loss of \$4,071.
- -Property Maintenance costs budgeted at \$65,613 came in at \$71,034. Net loss of \$5,421.
- -Pastoral Leadership costs budgeted at \$125,091 came in at \$122,630. Net loss of \$2461.
- -Christian Nurture costs were budgeted at \$41,275 came in at \$24,139. It appears we budgeted approximately \$10,000 too much for OWL expenses. A net gain of \$17,136.

As a result of the above factors net expenses decreased by \$5,000.

Additional donations in 2022:

- There were no significant donations in 2022 however we continue to utilize the Duringer fund donation of \$25,000 to improve audio visual equipment and the Light fund finances the concept of a new deck off the Riverview room. It's in the design and estimate phase.

#### 2023 Proposed Budget

The annual budget is proposed at \$323,725 for 2023. The council met on January 10 to consider the proposed \$30,000 deficit. Several factors apply to this budget request and hopefully mitigate its long term effect for the year.

## Budget Factors for the 2023 budget. Revenue

- Endowment fund 4.5% of 3 year weighted average is calculated at \$23,450.
- The payroll reserve fund of \$53,995. Calculating the increase requested for payroll increases for 2023; \$20,619 is to be transferred to the operating fund. The remaining funds are there to anticipate wage increases in the coming years.
- The Finance committee has been extremely conservative in estimating the fund raising at \$15,000.
- Only funds committed in the recent funding drive or reasonably counted on are shown as member income. Several regular contributions occurring in December of each year are not counted on for the budget development. The Lake Foundation contribution of \$10,000 is not shown as income because while it has arrived each year for the past several years it isn't a commitment on their part.

#### Expense

As spending occurs during the fiscal year our church has the capability to decrease expenditures if the revenue is shown to be reduced during the year. This is part of the flexibility built into our budget.

- We have budgeted \$8,614 for a capital project that may or may not be performed. We already have \$13,415 in our fund balance. As we do our strategic plan this year we can utilize these funds for both the consultant fees of approximately \$3,000 and also toward upcoming projects. We have shown that there may be a loan or fund drive for reroofing and floor repair. The source of these funds are not included in our budget.

#### **Summary:**

Assets of our church in the amount of \$735,662 reassure that we have the capital to cover costs even though we need to be vigilant not to get complacent about the fact that we need more members and income to accomplish our goals for the community.
